Mullis, Taylor forced into runoff in county elections

It finally happened in Peach County -- there was an election held.

But it's not over yet. There's another election in two weeks -- a runoff for the Post 4 seat on the County Commission.

However, winners were unofficially declared Tuesday night in the Post 2 County Commission and the Post 2 School Board races.

Challenger Matt Mullis collected 447 total votes and forced a runoff with incumbent Jack Taylor in the Post 4 commission race. Taylor pulled in 317 votes. Another newcomer, Glenn Hardison tallied 267 votes.

The closest race of the election, which had been called

off last November because of a redistricting suit, was for election whether they voted in the special election Tuesthe School Board Post II seat.

Incumbent Evangeline "Van" Carson regained her seat by garnering 396 votes to beat challengers Ruth Thompson (230 votes) and Evelyn McCray (160 votes).

Carson missed a runoff with Thompson by a single vote. In the Post 2 County Commission race, incumbent Anna Lumpkin kept her seat with a 554 to 217 vote margin over challenger Bill Nichols.

In uncontested races, Mike Gilstrap received 1,746 votes for the at-large School Board post he presently holds.

School Board incumbent Bill Dick received 762 votes in Post 4.


According to County Attorney Charlie Adams, every registered voter is allowed to vote in the Feb. 7 runoff

Winners will take office Thursday morning after vote results are declared official, according to Debbie Hunnicutt, election supervisor.

"I'm so glad I made it," said Carson over her cheering crowd which had gathered at the rear of the courtroom. "I just want to thank all my supporters for the fine job they've done for the past eight months. That one vote is just as good as a thousand"

Mullis said "I'll be glad when this is over. I just want to thank everyone for believing in me and showing their support.'

"I feel good about this, even with the runoff," said Taylor. "I want to thank everyone who had confidence in me and showed it with a vote."

on drugs

A concentrated effort aimed at placing emphasis on local drug sales has netted nine arrests for Peach County deputies.

According to Major Terry Deese, three people were arrested Jan. 10 and charged with trafficking cocaine after Capt. Craig Peavy of the Mid State Task Force found a bag containing more than eight ounces of crack cocaine on the floorboard of a Ford

Taurus he stopped on Interstate 75. Deese said Mario Garcia, 23, Enrique Serrano, 23, and Vicki Serrano, 29, all of Naples, Fla. were charged with trafficking cocaine. Garcia was also charged with giving false information, expired tag and driving with a suspended license, Deese said Garcia consented to a search of his car, and officers found 964 pieces of \$20 blocks of cocaine and eight \$100 blocks in a McDonalds bag.

Officers also seized \$2,200 in cash.

"The three said they were at a rest area in Virginia when two men began fighting and one threw the bag down," said Deese. "They said they picked it up and left. They said they knew it had cocaine in it and could make a lot of money.

Bond was set at \$25,000 each. All remain in Peach County Jail.

Deputies Charlie Cannon and Cornelius executed a search warrant Jan. 12 at Lakeview Apartments and arrested Mark Handspike, 26, of Hollywood, Fla., and Spencer Statham. 25, of Fort Valley. Both were charged with possession of cocaine and released on \$1,500 bond.

Dep. Cannon arrested Gary Simmons, 39, of College Street in Fort Valley, for possession of cocaine, possession of drug related objects and theft by taking on Jan. 17.

City OKs rezoning for sports lounge

Fort Valley City Council members paved the way for a sports lounge and restaurant Tuesday night, but tabled a request to rezone property on Martin Luther King from commercial to residential.

During it's regular monthly meeting, council members voted unanimously to grant a special land use permit to Kenneth Walton to refurbish the old Kell Building on South Camellia Blvd.

According to Walton, he plans to open a country-style, buffet restaurant on the first floor, a sports lounge on the second floor and a private club for business and civic meetings on the third floor.

Walton said he is presently working to have the building added to the National Historic

Register.

The building must be 80 percent restored before consideration for the National Historic Register. It's 75 percent restored now," he said.

After much conversation, the council tabled a request by Steve Prince and William Huckaby to rezone property on Martin Luther King from commercial to residential.

Huckaby said the land was zoned residential several years ago, but was changed to commercial.

"However, there seems to be more need for residential development here," he said. But Huckaby said he had no immediate

plans for the land.

At the request of Councilman Norman Fitzgerald, the request was tabled for 30 days. "I just don't feel comfortable with this," said Fitzgerald.

Library keeps fight alive at Council

Apparently, there's still hope for a new Peach County Library. Tuesday night, Library Director Gilda Stanbery-Cotney told members of the Fort Valley City Council that she had begun attempts to amend that state budget or become a line item in the state's 1996 budget.

"I will try every way I know to get in the 1996 budget," she said. She told council members that Peach County's initial request for funding was "kicked out of the cycle this year after county commissioners refused to sign the application."

"Without their signature on the application, we did not have a complete package," she said. "But, we have now added a footnote to the application stating that the county would not be responsible for funding of the construction or additions and we now have a signature." Stanbery-Cotney said the complete package has been forwarded to

state officials. "We are hoping the state budget will be amended to include Peach

County," she said. "That's something we'll have to wait and see." She said plans for a new library had been approved by the Library Board of Directors, as well as state officials.
